eLearning Platform (eLP) Licensing Terms and Conditions

These Terms and Conditions ("Terms") govern the licensing and use of the Learning Management System ("eLP") provided by Health Risk Screening, dba IntellectAbility ("Licensor") to the client ("Licensee"). By subscribing to the eLP, Licensee agrees to be bound by these Terms.

1. Definitions

- **User:** A User is defined as any individual granted access to the eLP, regardless of whether they actively access or engage with courses or content within the eLP. Each User account created or provisioned in the eLP counts toward the total number of Users for billing purposes.
- **Service Period:** The duration for which the eLP license is granted, set at one (1) year from the start of the subscription, unless otherwise agreed in writing.
- **Prepaid Users:** Users for whom the Licensee has prepaid the discounted per-user fee as part of the initial licensing agreement.

2. Licensing Fees

- **Base Fee:** A fixed annual fee of \$500, payable at the start of the Service Period, which grants the Licensee access to the eLP for the agreed number of Prepaid Users.
- **Prepaid User Fee:** A discounted rate of \$3 per User for the number of Users specified and prepaid by the Licensee at the start of the Service Period. This fee covers access for the entire Service Period (one year).
- **Additional User Fee:** For any Users added beyond the prepaid number during the Service Period, a fee of \$5 per User will apply. Additional Users are billed based on the number of Users provisioned in the eLP at the prior month's end.
- **Non-Refundable Prepaid Fees:** Fees paid for Prepaid Users are non-refundable, regardless of whether the Prepaid Users actively use the eLP during the Service Period.

3. Billing and Payment

- **Billing Cycle:** Billing occurs at the start of each month for Additional Users added to the eLP up to the end of the prior month. The Base Fee and Prepaid User Fees are invoiced at the start of the Service Period.
- **Payment Terms:** Unless otherwise agreed in writing, invoices are due within 30 days of issuance. Late payments may result in the suspension of eLP access.
- **User Count:** The number of Users for billing purposes is determined by the total number of User accounts provisioned in the eLP, as recorded at the end of the prior month, regardless of usage.

4. Service Period

- The eLP license is valid for a Service Period of one (1) year, commencing on the initial subscription or renewal date. The license will automatically renew for successive one (1) year periods unless the Licensee provides written notice of cancellation to Licensor at least forty-five (45) days before the end of the current Service Period. Upon expiration, the license may be renewed by mutual agreement, subject to the then-current pricing and terms.
- Access to the eLP will be provided for the duration of the Service Period, contingent upon timely payment of all applicable fees.

5. Responsibilities of Licensee

- The Licensee is responsible for managing User accounts. The Licensee may exceed the Prepaid User limits, understanding that any additional Users beyond the prepaid number will be billed at the higher rate of \$5 per User, as outlined in Section 2 (Licensing Fees).
- The Licensee shall provide accurate information for billing and account management purposes.

6. No Refunds

- All fees, including the Base Fee and Prepaid User Fees, are non-refundable. No refunds or credits will be provided for unused User accounts or early termination of the eLP license during the Service Period.

7. Modifications to Terms

- Licensor reserves the right to modify these Terms with 30 days written notice to Licensee. Continued use of the eLP after such notice constitutes acceptance of the modified Terms.

8. Governing Law

- These Terms shall be governed by and construed in accordance with the laws of Florida, United States, without regard to its conflict of law principles.
